Key stat: Interest in non-legacy currencies is up slightly, but 58% of US advertisers say they still need to learn more about them before putting them into action, according to an April 2024 survey from iSpot.tv.

Beyond the chart:

- Nielsen's position as the incumbent gives it an advantage, considering many advertisers lack the resources to pay for more than one currency provider, according to our <u>Ad Measurement</u> <u>Trends H1 2024</u> report.
- However, other currencies are making strides. Last month, Comscore became the first alternative currency accredited by the Media Rating Council for national and local TV measurement.
- As consumer viewing habits evolve, Nielsen is making a push for cross-media <u>measurement</u>, pivoting from measuring average commercial minutes to more precise individual commercial metrics, which will make it easier to measure the reach of a campaign across TV, <u>connected</u> <u>TV</u>, and digital video, per the report.
